(hereinafter referred to as "secret information").

Agreement as well as any other agreement relating to the activities defined in Clause 2 hereof, including information about the terms or contents of any such agreement, shall be secret and shall not be disclosed by either party, except as hereinafter provided. The foregoing shall apply notwithstanding the fact that any particular subject of an agreement may carry a lesser classification but for this clause.

Should any subject of an agreement be accorded a higher classification than "secret" by mutual consent of both parties then the highest of such classifications shall apply.

4. The parties will agree on mutually acceptable security procedures which will be reduced to writing, signed by the appropriate agencies and such security procedures will define and determine the proper means and methods for transmittal, distribution, use and storage of secret information which may be required by either party in order to perform effectively any Agreement between them. - S. This agreement may be amended only by a written document duly signed by the parties or their authorized representatives.
- 9. This agreement will be in force and effect for an indefinite period and may not be cancelled or renounced unilaterally.
- 10. Each party agrees and undertakes that the provisions of this Agreement will be binding upon and duly observed by all the agencies of the respective ministries of defence as well as by the armed forces of each country.
